2. Call SJWD at 791-2663 to verify funding is available before you purchase.
3. Purchase and install a District-approved hot water recirculation system.
4. After installation, call SJWD to schedule an appointment. Staff will verify installation of your system during their visit.
5. Have the completed application and a copy of your original dated receipt (or detailed contractor's invoice) ready for staff to pick up at the time of your appointment. Your receipt must be legible and show proof of your payment. Keep a copy for your records.

Terms and Conditions

1. The Hot Water Recirculation System Rebate Program will be administered by the San Juan Water District.
2. The Hot Water Recirculation System must be purchased between **July 1, 2016, and June 30, 2017**. Demand-actuated systems provide both water and an energy savings.
3. Systems should have approved safety code approvals from organizations such as UL or UPC with a satisfactory warranty. San Juan has worked with the Metlund D'MAND HWDS System. Although San Juan does not solely endorse Metlund or their product, Metlund has agreed to provide on-site, no cost workshops for SJWD customers and the general public.
4. To be eligible for consideration for participation in the program:
 - a. Property address where hot water system is installed must be located in the San Juan Water District retail service area.
 - b. Applicant must have an active water account with the San Juan Water District.
5. San Juan Water District reserves the right to verify the purchase and installation location of any system for which a rebate is provided.
6. Rebate program is subject to available funding. Rebates will be distributed on a first-come, first-served basis until funding is depleted. Submission of an application does not guarantee a rebate.
7. Only one \$100 rebate will be given per household.
8. Rebate will be issued in the form of a bill credit.
